Recently some fraudulent / unethical practices like un-informed outsourcing, fraud during sampling, usage of material from un-approved sources, welding joints which is not allowed as per T.S., tempering of test equipments etc. have been observed at some of the manufacturers works during regular inspections by POWERGRID.

In order to provide a strong deterrent to manufacturers from committing unethical practices, issuance of warning letter or imposition of penalty of Rs. 5 lakhs or withdrawal of approval & MQP of defaulting manufacturers shall be resorted to.

You are, therefore, requested to take care that none of the workers/executives in your premises is indulging in any un-ethical practices during manufacturing, inspection or dispatch from your
